The 230th meeting of the 'Standing Committee' addressed various agenda items, reflecting ESIC's commitment to effective governance and strategic planning. The discussions ranged from budget estimates to property management matters, emphasizing the ESIC's comprehensive approach.

The 'Budget and Accounts Sub-Committee (BASC)' discussed and recommended the 'Revised Budget Estimates 2023-24' and 'Budget Estimates 2024-25,' demonstrating ESIC's commitment to financial transparency and accountability.

ESIC actively participated in the All India Ayurveda Congress (AIAC) Conference and Arogya Fair in Mumbai, showcasing its AYUSH initiatives. The event included the sharing of the 'ESIC Policy on AYUSH- 2023' and highlighted efforts to promote AYUSH services. The presentation covered the current status of AYUSH in ESIC, services offered to ESI beneficiaries and future plans for the promotion of AYUSH services.

A three-day workshop on NABH Hospital 5th Edition Accreditation Standards was organized, encouraging the implementation of quality standards across ESIC Hospitals. This initiative aims to elevate the quality of healthcare services and empower healthcare professionals with the necessary knowledge and skills. The 119th ESIC Regional Board Meeting in Kerala discussed the successful implementation of the ESI Scheme in the state, showcasing ESIC's dedication to tailoring solutions to regional needs.

The 12th Central Sports Meet in Pune marked the inauguration of a five-day event celebrating sportsmanship and healthy competition among 605 participants in seven different disciplines. This emphasizes ESIC's commitment to promoting a healthy lifestyle and fostering camaraderie.

Hon'ble Members of Parliament participated in a study visit to Goa, focusing on rules and regulations under the Employees' State Insurance Act, 1948. This initiative showcases ESIC's transparency and willingness to engage in constructive discussions with stakeholders. The official language-related inspection of ESIC Regional Office, Ahmedabad and ESIC Model Hospital, Bapunagar, Ahmedabad, reinforces ESIC's commitment to linguistic compliance.

The provisional payroll data for November 2023 reveals remarkable development for the nation's workforce. ESIC has witnessed a substantial surge in enrollments under the ESI Scheme, adding 15.92 lakh new workers. A significant portion of these new registrations, totaling 7.47 lakh, comprises young employees aged up to 25 years. Gender diversity is a key focus, with 3.17 lakh female employees enrolled and a noteworthy stride towards inclusivity is the registration of 58 transgender employees. In addition, ESI Scheme expanded its coverage by registering approximately 20,830 new establishments.

As we move forward, ESIC remains steadfast in its dedication to delivering essential social protection benefits. Guided by principles of innovation, excellence and inclusivity, we look toward contributing to a resilient and prosperous nation, ensuring the well-being of all.

The hospital, situated on a sprawling 7.54-acre site, has been developed at an estimated cost of approximately Rs. 100 crores, with a targeted completion date of January 25, 2024, the facility is poised to become a vital healthcare hub in the region.



During his visit, Dr. Rajendra Kumar toured the hospital premises, starting with a thorough examination of the Outpatient Department (OPD) consultation rooms and the casualty area on the ground floor.

The patient demonstrated remarkable post-procedure recovery, being ambulatory the day after the intervention and subsequently discharged on the third day.
