Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

Buyer Added Bid Specific Additional Terms and Conditions

- 1. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration
- 2. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
- 3. Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
- 4. AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.
- Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of ESI Fund A/C No. 1 payable at

Pune

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

6. Buyer Added text based ATC clauses

The successful bidder has to provide one ambulance of the type C category of the specification mentioned in technical specification of the bid along with round the clock driver in 3 (Three) shifts. The drivers provi ded by the successful bidder must have an experience of 2 years and also have basic knowledge of First A id and ABC resuscitation in case of medical emergency.

The ambulance must be fitted with GPS Tracker with a provision to track the ambulance by the hospital au thority, Fan and minimum 15/16 Amp. power point (socket).

The successful bidder shall sign a contract agreement with the Medical Superintendent of ESIC Hospital Bi byewadi after the award of the bid on a stamp paper of Rs. 500. The cost of stamp paper shall be borne b y the service provider. A list of terms & conditions of the contract has been uploaded. If any bidder submit s the bid, it means he is agreed to the terms & conditions mentioned/attached to the bid. A list of equipme nt to be provided with the ambulance is also specified in uploaded document. Bidder may kindly go throu gh it carefully.

Medicines kit will be provided by the buyer.

Bidder should upload the following documents in Technical bid.

- 2. EPFO Registration certificate

4. GST Registration Certificate

10. Bid securing declaration on a stamp paper of Rs. 100 duly signed by the bidder or Authorized signator y of the Bidder

Terms and conditions of the original bid of Monthly Ambulance Services published vide GEM/2024/B/4662 636 dated 01.03.2024 is modified to the extent as per details given below:

1. EMT is not required. Hence, wherever the word EMT has come in the original bid document, it may be tr eated as null & void.

- 2. 2. Model of ambulance- 2021 or higher.
- 3. 3. The bidder has to quote the rate considering all cost as per requirement of the bid. No enhancement wil I be given during the period of contract.

4. As of now ambulance services are exempted from GST. However, in future, if GST is made applicable t o ambulance service, the cost will be borne by the buyer."

5. Remaining terms and condition will be same as published in original bid.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
